Neal is a nationally recognized health care industry thought leader and strategist, who works with executive teams and boards to develop fresh thinking on organizational opportunities, market strategies, and potential partnerships. Working with over 500 health care organizations in the last 25 years, Neal serves as a trusted advisor to health systems, academic medical centers, multispecialty physician groups and health plans.

As Chairman of GreenRobe Inc., Neal works with clients to design approaches for health systems to enhance their brands and create new profitable revenue streams in consumer products and services markets.

Neal is a member of the board and Chairman of the Strategy Committee for INTEGRIS Health, which operates 16 hospitals and has health providers in 49 Oklahoma towns and cities. He is Vice Chairman of the board of Health Payment Systems, which transforms health care billing with an all in one solution. He is a private equity investor in several healthcare IT startups, including Pascal Metrics, which pioneered the use of real-time triggers from the EHR, EMR, and other health IT to support patient safety and quality improvement, and allow responsive risk management.

Neal also consults with leading healthcare organizations as a Senior Advisor for BDC Advisors. In this capacity he has partnered with a broad range of organizations to develop strategic plans, and to lead specific projects including ACOs, CINs, physician networks, retail clinics, and partnerships and mergers. Neal is the founder of the Collaborative Care Colloquium a group of over 20 clinically integrated networks that meets regularly to share best practices on operating physician networks.

Prior to this, Neal worked as a Principal and Managing Director of the Advisory Board Company and was part of the team that took the company public in 2001. Neal led the team's annual CEO Sessions and taught thousands of healthcare executives through that program. He oversaw the breadth of the firm's educational programs and developed the firm's consulting capability, H*Works, and its leadership development programs, Advisory Board Leadership Academy (which includes programs such as Nursing Leadership Academy and the Physician Leadership Academy).

Neal has worked on healthcare issues with organizations ranging from the Massachusetts General Hospital and The Mayo Clinic, to United Healthcare and the Blues, to IBM and the US Navy. He is sought after as a speaker and facilitator for board retreats, executive education programs and national meetings.

Neal has a PhD in the History of Science from Harvard University where he also taught courses in the history and sociology of medicine. He has lectured at Cambridge University and Tufts University and has served as an adjunct faculty member in executive education at the Johns Hopkins School of Nursing. He has several publications, including his book on the history of medical malpractice, *Unhealed Wounds*.
